Hawking STEAM Charter School values its collaborative partnerships with community members which has been further strengthened since March 2020 due to the COVID-19 pandemic and the multitude of school plans that have been developed. Hawking solicits input from its community members on an ongoing basis most recently with the development of the school's 2021-22 Local Control and Accountability Plan (LCAP), AB 86 Expanded Learning Opportunity Grant (ELO-G) and currently with the development of this plan.

Members of the Hawking Administrative Leadership Team meaningfully consulted with its students through online survey; while families/guardians were consulted during virtual meetings, return to in-person instruction parent conferences, Parent Advisory Committee (PAC), and through applications to communicate with families - Class Dojo and Messenger. Our bilingual staff provides interpreter services; and all materials sent to families are translated to Spanish to ensure families that speak other languages provided public input. Families of Unduplicated Pupils (English Learners, Low-Income, Foster youth); and families of Students with Disabilities were also consulted and provided opportunities for public input in the development of this plan. Accommodations as appropriate are made for family members with disabilities including providing information and school reports in a format (to the extent practicable) in a language that parents understand.

Hawking's Administrators including the Executive Director, and Principals at each site, Leadership Teams at each site, Special Education Administrator (Special Education Coordinator), and Foster Youth/Homeless Liaison, participated in regular meetings in preparation for the return of in-person instruction; and meetings that continued in August and September 2021 focused on strategies

to address the academic impact of lost instructional time, addressing social-emotional/behavioral needs of students, and strategies to support our educators.

The Special Education Administrator (Special Education Coordinator) consulted with our SELPA Provider - EL Dorado Charter SELPA during virtual meetings to further gather input/feedback from a community member advocating and representing the needs of Students with Disabilities. Hawking's Executive Director consulted with South Bay Community Services and San Ysidro Health—representing Community Partners and community organizations.

Hawking STEAM Charter School's Administrative Leadership Team collected and analyzed community input to identify evidence-based strategies and interventions to address the academic impact of lost instructional time, and identify other strategies or activities influenced by community input.

- Hire an additional Counselor
- Psychologist to provide additional SEL/Mental health/counseling services for SWD.
- Return to field trips (once it is safe to do so)
- Provide additional clubs/organizations, including Wellness clubs
- Opportunities for parent engagement
- Reading & Math Interventionists to provide Tier 2 targeted supports

- Parent Education resources/workshops
- Expand access for after-school program

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before September 30, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

- Planning for, coordinating, and implementing activities during long-term closures, including providing meals to eligible students, providing technology for online learning to all students, providing guidance for carrying out requirements under IDEA, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements;
- Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
- Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;
